1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2020-21 was £8.32 per elector.

In 2020-21, the Council made payments totalling £ 5,500.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

2. WAO have advised that the 2019-20 Annual return had not been received and it was noted that the 2019-20 internal auditor had not provided a comprehensive audit report. As a result the Annual Governance Report (section 1) on page 3 above has been completed to reflect the comments made by the Internal Auditor who had reviewed the accounts and governance for the 2020-21 Annual return. An action plan is to be drawn up to address the issues raised.


